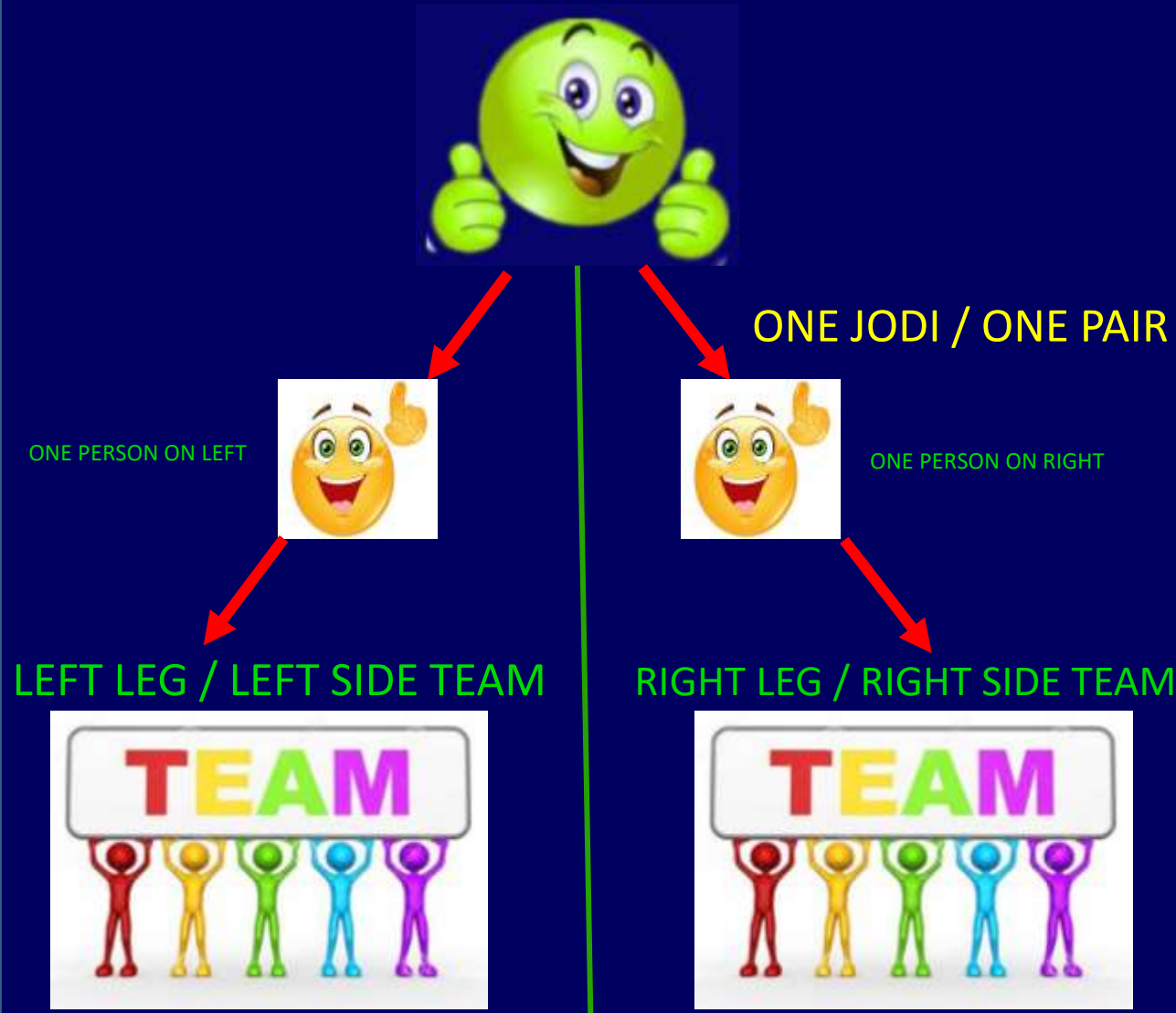

SMART BINARY (SB)

HOW IS THE PAIR (JODI) VALUE DERIVED ?

LET US UNDERSTAND STEP BY STEP
WITH THE HELP OF AN EXAMPLE

- ✓ You can join by purchasing any one of the package.

FOR EXAMPLE

- ✓ In a particular week the total number of sales at company level is 100.
- ✓ Company keeps aside **1100 Rs.** Per sale for Smart Binary.
- ✓ **In this case 100 Sales X Rs. 1100 = 1,10,000**

SMART BINARY (SB)

HOW IS THE PAIR (JODI) VALUE DERIVED ?

FORMULA FOR CALCULATING
PAIR(JODI) VALUE

$$\text{PAIR VALUE} = \frac{1100/- \times \text{COMPANY WEEKLY SALES}}{\text{NO. OF PAIRS MATCHED WEEKLY}}$$

Eg. WEEKLY PAIRS MATCHED AT COMPANY LEVEL

SMART BINARY (SB)

HOW IS THE PAIR (JODI) VALUE DERIVED ?

LET US UNDERSTAND NEXT STEP...

$$150 \text{ Pairs} = \frac{1,10,000}{150} = 733/- \text{ Per Pair}$$

$$200 \text{ Pairs} = \frac{1,10,000}{200} = 550/- \text{ Per Pair}$$

$$250 \text{ Pairs} = \frac{1,10,000}{250} = 440/- \text{ Per Pair}$$

$$350 \text{ Pairs} = \frac{1,10,000}{350} = 314/- \text{ Per Pair}$$

$$440 \text{ Pairs} = \frac{1,10,000}{440} = 250/- \text{ Per Pair}$$
